BOARD OF ALDERMEN
MINUTES OF PUBLIC/SPECIAL MEETING
TUESDAY, JANUARY 7, 2025**

The Mayor and Board of Aldermen met on Tuesday, January 7, 2025, at the City Hall in Roseland, Louisiana for a Special Meeting.

Mayor Van Showers called the Special Meeting at 5:15 p.m.

The following Aldermen were present at roll call: Carrollannia Y. Johnson, Sandra Turner, Katina Bates, and Wanda Y. McCoy. Aldermen Kevin Robinson was not present.

The Prayer was led by Sandra Turner. The Pledge of Allegiance was presented by Carrollannia Y. Johnson.

The Minutes for the Special Meeting for December 10, 2024, was reviewed.

The Minutes for Public Hearing/Regular Meeting for December 12, 2024, was reviewed.

Reviewed Accounts Payable for December 2024 were reviewed.

Ordinance #348 was introduced by Sandra Turner, Amending the Compensation of the Mayor and Board of Alderman, \$50.00 increase each month for Alderman and \$ 200.00 increase a month for Mayor a month, which will include all meetings. (One-time payment, flat rate per month)

There will be a meeting held once a month, which will include the Special and Regular Meeting. Will inform everyone of month when once a month meeting will begin.

Wanda Y. McCoy introduced Katina Bates to everyone at the meeting, informing her of everyone's position.

The Resolution was approved to Designate Authorized Signers for banking purposes. Mayor Van Showers requested Sandra Turner, Carrollannia Y. Brooks, and Mayor Van Showers. Sandra Turner Motioned the Resolution to Designate Authorized Signers for banking purposes, second by all in favor, Carrollannia Y Brooks, Wanda Yodie McCoy and Katina Bates, Resolution passed.

On old business, Dogs and condemnation & demolition of buildings/high grass and weeds is enforced. Ordinance to enforce dogs that are unleashed and running wild. Once the Zoning Board is formed, they will be responsible for going to property that is being neglected. We will be keeping Animal Control.

Mayor Van Showers Appointed Sharlet K. Johnson, Town Clerk, motioned by Wanda Yodie McCoy, seconded by Sandra Turner, Carrollannia Y. Johnson and Katina Bates all agreed, Motion passed.

Carrollannia Y. Johnson Motioned that First Guaranty Bank will be Designate Fiscal Agency, second by Katina Bates. Wanda Y. McCoy, Sandra Turner in favor, Motion passed.

Motioned by Wanda Y McCoy, that Daily Star Designate be Official Journal, second by Katina Bates, Sandra Turner, Carrollannia Y Johnson agreed, Motion passed.

A motion to adjourn was made by Sandra Turner, second by Wanda Y. McCoy. Carrollannia Y Johnson voted to approve. The motion passed unanimously, and the meeting was adjourned.
